

**MINUTES OF THE HUNTON ANNUAL PARISH MEETING  
HELD ON MONDAY 18<sup>TH</sup> MAY 2015  
AT HUNTON VILLAGE HALL**

**PRESENT:** Cllr G Thomas as Chairman, Cllrs R Sawtell, A Trought, S Wyles, R Porter, T Stanbridge and D Heaton and Mrs S Goodwin, Clerk. They were joined by at least 15 members of the public.

**1. CHAIRMAN'S WELCOME**
