**3. Matters Arising**

The following, which took in several later items on the agenda, were discussed:-

Boundaries

A quote in the sum of circa £800 less VAT had been received from Chris Acaster. This included the trimming of the mixed boundary hedge running along the left hand side of the Field from the road to Savage's boundary, and the trimming of the beech hedge in front of the Village Hall. The Secretary was instructed to agree this figure and to put the work in hand. To be completed as soon as possible.

Facilities for children and young people & Play & Sports Equipment

This is ongoing.

Footpath from Bensted Close to the Hall

Written confirmation had been received from Mr Gilbert confirming agreement to a permissive footpath and it was hoped that following discussions with the KCC some progress would be made shortly. DP raised the question of whether the proposed construction of the footpath would make it accessible for disabled persons in motorised chairs, and also for prams. It was generally felt that this would be the case, but that the matter should be given further consideration.

**Health & Safety**

There was no current Play Area Inspection Report to consider at this time. The surface the multi ply still required attention. The Safety netting along the Bowls Club boundary had been repaired.

**Other Parish Matters**

The Chairman had received an invitation from the Chair of the Hunton Parish Plan Steering Committee to attend a meeting to give the input of the Sports Clubs to the Steering Committee. Simon Taylor agreed to attend the meeting on behalf of the Committee and the Secretary was requested to collate the individual views of each Club.
